This comment is in relation to the Prior Period Adjustment of \$853,801 in Part XI - Reconciliation of Net Assets. In the 2020 filing, we mistakenly understated the ending balance of net assets by 264,792, the amount of net income. This caused an under valuing of the 2020 ending balance, which was also reflected as the beginning balance of 2021. Through this prior period adjustment, we have rectified this mis-calculation going forward.
